

ORDINANCE NO. 2000-3

An Ordinance of the Township of West Pikeland, Chester County, Commonwealth of Pennsylvania under authority of the Pennsylvania Motor Vehicle Code Establishing No Parking Zones in Certain Areas and Stop Intersections at Certain Areas Within the Township.

The Board of Supervisors of West Pikeland Township does hereby enact and ordain as follows:

Section 1. Parking is prohibited at all times and “No Parking” signs shall be erected at the following locations:

Street	Side	Between
State Route 113	Both	Entire length within the Township
State Route 401	Both	Entire length within the Township
Yellow Springs Road	Both	Route 113 and Art School Road
Horseshoe Trail	Both	Route 113 to Highview Drive
Pikeland Road	Both	Route 113 to Dogwood Lane
Art School Road	Both	Clearview to the Creek

In any legally posted Handicap Parking Zone unless vehicle has necessary handicap placard and/or license plates.

In any posted or officially marked fire zone.

Section 2. The following intersections are established as stop intersections and the erection of official stop signs in such position as to face traffic in the direction or directions hereby indicated is hereby authorized:

North Saddlebrook Circle Eastbound at French Creek Lane
Pickering Circle Northbound at North Saddlebrook Circle
Saddlebrook Circle Westbound at French Creek Lane

Pine Creek Road Northbound at Davis Road
Fox Lane Southbound at Davis Road
Hunt Club Lane Southbound at Davis Road
Hunt Club Lane North and Southbound at Bridle Lane
Fox Lane North and Southbound at Bridle Lane
Upper Pine Creek Road Southbound at Davis Road
Hunt Club Lane Westbound at State Road Route 113
Fairfields Lane Eastbound at State Road Route 113
Collins Mill Road Northbound at Fairfields Lane

Section 3. If any part of this Ordinance is declared invalid, such declaration shall not affect the remainder.

Section 4. This Ordinance shall take effect 5 days after enactment.
