2) Persons Wishing to be Heard:

- a) John Matthews reported for the EAC.
- b) EAC met to investigate solar panels for buildings at Pine Creek Park.
- c) There will be a shredding event (4 box max) at the Township Building, on November 14, 2020. All paper no plastic. Details on the township website.
- d) May name small streams in township. Will work with surrounding townships to keep stream names consistent between townships.
- e) Continuing to push conservation/renewable energy effort with the township. Rebranding name to make it more generic.
- f) Composting site may be set up in near future in our township.

- b) We recommend using 2020 budget funds to buy trail signs to clearly mark trails in Walnut Lane Park from the parking lot to the trailhead and from the park to Anselma Mill's trails.

 - i) Jodi will follow up with details on number of benches and locations.
