ORDINANCE NO. 2005-205

THE MUNICIPALITY OF WEST PIKELAND TOWNSHIP CHESTER COUNTY, PENNSYLVANIA

AN ORDINANCE PROHIBITING PERPENDICULAR AND ANGLE PARKING OF VEHICLES ALONG ART SCHOOL ROAD BETWEEN YELLOW SPRINGS ROAD AND PIKELAND ROAD

The Board of Supervisors of WEST PIKELAND TOWNSHIP, Chester County, Pennsylvania, pursuant to Section 2328 of the Second Class Township Code, hereby ENACTS and ORDAINS as follows:

SECTION 1. Definitions.

a. For purposes of this Ordinance, the following words and phrases shall have the meanings indicated:

"Subject portion of Art School Road" shall mean that portion of Art School Road in the Township between its intersection with Yellow Springs Road and its intersection with Pikeland Road.

"Township" shall mean West Pikeland Township, Chester County, Pennsylvania.

"Zoning Ordinance" shall mean the West Pikeland Township Zoning Ordinance, being Ordinance No. 2005-201, adopted April 25, 2005, as may be amended from time to time.

- b. For further purposes of this Ordinance, words and phrases used in this Ordinance, which are also used in the Vehicle Code, 75 Pa.C.S. §101 *et seq.*, shall have the meanings given such words and phrases in the Vehicle Code.
- c. This Ordinance is subject to all applicable provisions of the Zoning Ordinance. For further purposes of this Ordinance, words and phrases used in this Ordinance, which are also used in the Zoning Ordinance, shall have the meanings given such words and phrases in the Zoning Ordinance.
- SECTION 2. <u>Prohibition</u>. Perpendicular and angle parking of vehicles on the subject portion of Art School Road is hereby prohibited.
- a. Any landowner providing access or area for such perpendicular and/or angular parking on the subject portion of Art School Road shall convert such parking spaces to parallel parking spaces in accordance with SECTION 5 herein, or otherwise take appropriate measures to eliminate all such perpendicular and/or angle parking spaces.

- b. This prohibition shall hereby require all applicable landowners to eliminate such perpendicular and/or angle parking spaces to the extent spaces are designated for same.
- c. This prohibition shall hereby require all persons parking vehicles along the subject portion of Art School Road to cease from such perpendicular and/or angular parking on the subject portion of Art School Road.
- SECTION 3. <u>Enforcement</u>. The Township Roadmaster or other appropriate Township Official is hereby authorized to enforce the prohibition under Section 2, which includes requiring appropriate signage as may be necessary.
- SECTION 4. <u>Penalties</u>. Any person in violation of Section 2 shall be guilty of a summary offense and shall, upon conviction, be sentenced to pay a fine of up to \$500.00, plus costs. Each day that such violation continues shall constitute a separate offense.
- SECTION 5. <u>Permitted Parking</u>. Parallel parking along the subject portion of Art School Road is permitted in accordance with the parking size and design standards set forth in §1207 of the Zoning Ordinance, as may be amended from time to time, and Article XII, <u>Off-Street Parking and Load Provisions</u>, generally.
- SECTION 6. <u>Severability</u>. The provisions of this Ordinance are severable. If any section, paragraph, clause or phrase of this Ordinance is declared unconstitutional, illegal or otherwise invalid by judgment or decree of a court of competent jurisdiction, that invalidity shall not affect any of the remaining sections, paragraphs, sentences, clauses or phrases of this Ordinance.

SECTION 7. <u>Effective Date</u>. This Ordinance shall be effective five (5) days from the date of enactment.
